Executive Summary/Major Accomplishments

This State Fiscal Year (SFY 2025) Quarter 1 Report is submitted to the Montana Department of Transportation (MDT) and the U.S. Department of Transportation, Federal Highway Administration (FHWA) to provide details on the activities and project work of Montana LTAP in support of MDT Project No. 02443, Montana Local Technical Assistance Program.




Figure 1: Q1 training participation by customer type

From July to September 2024, LTAP hosted 352 in-class participants, in 16 different classes taught at 12 different locations, accounting for 95 hours of instruction, with a reach of 2,054 inperson contact hours. Course enrollment tends to be lower in Quarter 1 due to our customers' seasonal workload, as the summer months are the busiest for heavy construction and maintenance work. Figure 1 and Table 1 provide an overview of training attendance by customer type.

Training Overview




Figure 2: Number of training classes by focus area delivered during Q1

During Q1, LTAP provided 16 trainings under the Safety, Infrastructure Management, and Workforce Development (Equipment Operations) focus areas. Figure 2 illustrates the distribution of classes delivered per focus area. Note that Workforce Development is divided between Equipment Operations and Flagging.

In addition to the three focus areas delivered to customers, MT LTAP personnel participated in an Organizational Excellence (professional development and leadership training for LTAP personnel) activity – attending the National NLTAPA Conference in Albuquerque, New Mexico in July.

This Quarterly progress report further details these activities by focus area:

- Safety
- Infrastructure Management

Focus Area: Safety

Safety is incorporated into all classes, hosted activities, technical assistance, and training. This includes messages on Toward Zero Deaths, seatbelt usage, and distracted driving, as well as the LTAP personal safety classes, work zone safety, and roadway and operations/maintenance safety.

Safety efforts this quarter included:

- Personal Safety Confined Space class and Mower Safety Webinar
- Day 1 of the Snow Rodeos in Sidney and Missoula: Trenching and Excavation Safety

These courses accounted for 23 of the 95 class hours delivered this quarter and reached 109 (45%) of the 352 total customers taught this quarter.

Focus Area: Infrastructure Management

Infrastructure management is a foundational topic that is integrated into multiple courses, both as a primary focus and as a supporting element. Montana LTAP recognizes the growing need for improved infrastructure management systems and is actively promoting this area. To address this need, we recommend courses that emphasize maintaining accurate inventories of culverts, cattleguards, and signs, as well as implementing effective pavement management and condition assessment strategies.

Infrastructure Management was the primary focus of one LTAP course offering this quarter. The six-hour training welcomed 18 participants in Joliet, MT and covered Gravel Road Fundamentals and PAvement Surface Evaluation & Rating (PASER) for Gravel Roads.

This training accounted for 108 contact hours with our customers, and reached 18 (5%) of the 352 total customers taught this quarter

Focus Area: Workforce Development

Workforce development remains a high-demand course type, primarily driven by our customers' expressed needs. The recent Bipartisan Infrastructure Law (BIL) has placed a strong emphasis on workforce development, suggesting increased opportunities for new course content and offerings.

Workforce training is essential for our local agencies, and when combined with personal safety training, we can effectively reach employees at all levels. We consistently receive positive feedback from our city, county, and tribal customers, who appreciate our ability to equip their workforce with the skills needed to effectively manage, operate, and maintain their roadways. Given ongoing turnover and worker shortages, workforce development continues to be a critical component of our program delivery

Workforce Development comprised eleven of our 16 classes, or 69% of our class delivery this quarter. Trainings for Q1 included Day 2 of our Annual Snow Rodeos in Missoula and Sidney, as well as Grader Operations Basics, Skid Steer, Forklift, and Flagging Certifications. These accounted for 1406 customer contact hours.

LTAP will continue to work toward offering more in-house Motor Grader Operation training this year. We have held this class in Teton County this quarter, and it was highly successful based on feedback from the attendees. LTAP has also hired a part-time instructor to assist with these road grader classes this fiscal year. Table 4 provides Montana LTAP's schedule of Workforce Development trainings, the communities served, attendance levels, and total contact hours.

Focus Area: Organizational Excellence

To provide the best service possible to constituents, LTAP personnel seek and attend training and other professional development opportunities to improve their outreach capabilities. Activity in NLTAPA, APWA, NACE, and other organizations is supported and encouraged by FHWA Center for Local Aid Support (CLAS) and our partners.

Organizational excellence addresses professional development and leadership training for LTAP personnel. This also includes professional support of our staff through activities in nationally significant organizations, support of our customers and partners, and partnering efforts with our sponsoring agencies (FHWA, MDT, and MSU).

Examples of partnering efforts with sponsoring agencies include hosting the Asphalt Conference with MDT, annual meetings with FHWA, MSU statewide initiatives with the Western Transportation Institute and the Norm Asbjornson College of Engineering, and initiatives with FHWA such as Every Day Counts (EDC) and Build a Better Mousetrap (a celebration of local innovations).

Challenges

• MT LTAP is working to accommodate multiple on-demand requests for grader training. Scheduling is a challenge as grader courses are best delivered when there is moisture on the roads. This quarter was complicated by unseasonably dry conditions coupled with counties' commitments to other summer infrastructure projects. Q2 will be dominated with snow operations preparations and Fall MACRS trainings, but we are striving towards including a class on Motor Grader operations. We plan to resume scheduling the hands-on classes as requested in spring (Q3).
