Executive Summary/Major Accomplishments

This State Fiscal Year (SFY 2024) Quarter 3 Report is submitted to the Montana Department of Transportation (MDT) and the U.S. Department of Transportation, Federal Highway Administration (FHWA) to provide details on the activities and project work of Montana LTAP in support of MDT Project No. 02443, Montana Local Technical Assistance Program.




Figure 1. Quarter 3 Training Attendance by County

Providing instruction to our local customers is at the heart of LTAP. While January through March of each year can be a slow time for training requests and in-state travel, Q3 was busier this year. The latter part of March always increases participation numbers due to the Annual MACRS Conference and the mild winter conditions experienced by Montana this year resulted in a large amount of local trainings as well. LTAP hosted a total of 1,297 in-class participants, 47 different classes taught at 23 separate locations, accounting for 282 hours of instruction, with a reach of 7,809 contact hours across the state. Figure 1 provides an overview of local agency participation, with county representation as the largest participant. Table 1 provides an attendance comparison to SFY 24 Q1 and Q2.

Training Overview




Figure 2: Number of training classes by focus area delivered during Q3.

During Q3, LTAP provided trainings covering Safety, Infrastructure Management, Safety + Workforce Development, and WFD-Leadership focus areas. LTAP also participated in several Center Excellence activities. Figure 2 summarizes the percentage of trainings offered by type. This progress report further details these activities by each focus area: Safety, Infrastructure Management, Workforce Development, and Organizational Excellence.

Focus Area: Safety

Safety is incorporated into all our classes, hosted activities, technical assistance, and training. This includes messages on Toward Zero Deaths, seatbelt usage, and distracted driving, as well as the LTAP personal safety classes, work zone safety, and roadway and operations/maintenance safety.

Safety-focused classes accounted for 7% of our class delivery in Q3 and included a safety webinar and a CPR/First Aid class. Combined with Workforce development, the Safety + Workforce Development accounted for 72% of our delivery, and included 12 flagger certification classes, 3 OSHA 10 courses, and numerous other classes.

Figure 3 provides Montana LTAP's Q3 schedule of specific safety related trainings provided, the communities served, attendance levels, and total contact hours.

Focus Area: Infrastructure Management

The Infrastructure Management area of focus is broad enough that it is a component of many classes in whole or in part. Montana LTAP is promoting more attention on Infrastructure Management as we see a need for better systems to assist our customers in managing their assets and infrastructure. To do this, we often suggest classes that focus on maintaining culvert, cattleguard, and sign inventories, pavement management, and condition assessment methods. We sometimes have a lukewarm reception to these suggestions, but they are an important part of what LTAP provides.

Infrastructure Management comprised 8% of our LTAP Course offerings this quarter and included a webinar, a gravel roads class, and a paving compaction summit in Helena.

Training: Workforce Development

Focus Area: Workforce Development

LTAP customers consistently communicate the need for Workforce Development. It is an area of focus in the current Bipartisan Infrastructure Law (BIL), and we expect to see more opportunities for added content and classes moving forward. Workforce training is foundational for our locals and when combined with personal safety, we can successfully reach most of our locals at all levels of the agency. City, County, and Tribal customers continue to provide positive feedback regarding our ability to help prepare the workforce to meet the regular challenges of owning, operating, and maintaining their roadways. Worker turnover and shortages in the public sector throughout the State of Montana will continue to make this an important part of our program delivery.

Workforce Development and Leadership comprised 65% of our class delivery this quarter. Workforce development trainings for Q3 included Skid Steer, Forklift, MHSA Refreshers, Flagging Certifications, and a host of other classes. Figure 5 provides the schedule of Workforce Development and Leadership trainings delivered in Q3.

General Highlights

Highlights of Montana LTAP's Q3 accomplishments include:

- A new class of Road Scholars and Road Masters achieved their certificates at the annual MACRS Conference in Great Falls in March.
- The annual MACRS conference in Great Falls was well attended and all reviews have been incredibly positive. This event requires a huge effort and amount of resources to assist with the preparation, planning, and execution. The annual meeting planning committee, LTAP Staff, and MACRS did an excellent job making this happen.

Challenges

- LTAP is working with the Asphalt Institute and MDT to help plan this year's Asphalt Conference. Timing (coordinating the event date and venue availability) and content (availability of speakers) has been a challenge this year, but we anticipate another great conference. The conference is planned for Q4.
- We continue to work with Blaine County in their search for more effective ways to source and produce gravel through a Technical Assist. They have asked for guidance on finding suitable sources and processing methods to get the best products that can be made from the materials that they have access to in the County. We anticipate this to be an ongoing technical assist.
